

On September 5, 2014, the governments of Nagasaki Prefecture and Sasebo City filed for a determination to authorize them to execute a forcible expropriation of lands owned by anti-dam residents in order to build the Ishiki Dam on the Ishiki River, which runs through Kawatana-cho, Higashi-Sonogi-gun, Nagasaki. The total area of farmland subject to this recent application is approximately 5,000m², however the remaining land of 145,000m² to be targeted next is home to 13 households and 60 people. The construction of Ishiki dam will destroy the lives of these residents as well as the precious ecosystem of Ishiki River which includes the endangered fish called Yamato Japanese Spined Loach, other freshwater fish and Genji Fireflies. Furthermore, the water quality of Ishiki River will decline, causing extreme concerns regarding the impact it will have on the mainstream called Kawatana River and onto Omura Bay.

1. Project Overview

The proposed dam site is located at Kawatana-cho, Higashi-Sonogi-gun. The governments of Nagasaki Prefecture and Sasebo City plan to build the Ishiki Dam on the upper part of Ishiki River, a small stream with a total river length of about 4.6 km which joins Kawatana River which flows into Omura Bay about 2 km upstream of the river mouth

- Purpose: multi-purpose of 1) Access to municipal water, 2)
 Flood control, 3) Maintenance and improvement of river functions
- Height: 55.4 m Length: 234 m
- Construction Cost: 28.5 billion yen

% The total project cost is expected to increase up to 53.8 billion yen including construction cost of water supply facilities such as conveyance structures and water treatment plant. Out of this amount, 29.9 billion yen is the contribution of Sasebo City. Budget execution rate as of fiscal 2013 is 51.8%.

2. History


- 1962: Dam construction plan surfaces
- 1972: The plans start to get carried out. The government of Nagasaki Prefecture and local residents exchanged a memorandum stating "Do not move the plan forward without local residents' consent"
- 1975: Local residents established an union that opposes the construction of Ishiki dam.
- 1982: The government of Nagasaki Prefecture dispatched the riot police and enforced the survey of lands.
- 2009: The government of Nagasaki Prefecture filed an application for project recognition based on Land Expropriation Law to
 execute a forcible expropriation of land of anti-dam landowners with the Japanese government.
- September 2013: The project receives official recognition as a business.
- December 24, 2014 The government of Nagasaki Prefecture announced the implementation of on-site investigation to conduct surveys and measurements of houses as early as the middle of January to calculate the amount of compensation toward the 2nd application for determination on a forcible expropriation.
- January 13 -15, 2015 The government of Nagasaki Prefecture executed an on-site investigation, however the residents
 prevented it from being carried out.

3. Problems pertaining to Ishiki dam project

- Necessity of the Ishiki dam is lacking in grounds
- Water Supply purpose : Story of water shortage has been fabricated out of made-up predictions of water demand and underestimated secured sources of water.
- Flood Control purpose : Once the river channel improvement measures are completed, the required degree of safety against flood will be secured, making the Ishiki dam unnecessary.
- ✓ Environmental Impact : Lack of proper conservation measures
- The response of the government of Nagasaki Prefecture can be said to be an abuse of human rights

4. Key Schedules

- Current September 2017 (validity period of project recognition up to 4 years)
- In order to construct the dam without the consent of landowners, the government of Nagasaki Prefecture shall file the application for determination on expropriation of land not yet acquired with the prefectural expropriation committee. If a landowner does not vacate the property and building by the due date after the decision of determination is made, the government shall demolish the building by the way of administrative subrogation
- April May. 2015: The prefectural expropriation committee will decide on the case pertaining to the 5,000m2 of farmland owned by 4 families.
